There I finally came to see the box this Saturday pm.

The EDH, a few comments;

I see there is no collaboration letter establishing the use of the contents for a non commercial activity nor value and the collaboration between your institute and CERN, highly recommended, Kirsti.

The EDH is for "permanent" shipping implying that CERN has made a donation? I have never made out such. Is there a justification, from the DG etc?

Line 1 is expensive for "flat fiber glass".

Line 7 this is for the copper foil (0.035mm?) and the 6mm tube? it is not explicit. Anything else? see line 17.

Line 11 I guess tubes of adhesive?

Line 12 Are these the new FEBs? These are high tech FPGAs AND I have not checked this in the OCB for SECO! Can we put a date on this fabrication origine?

It must date from early 2000s. I understand they are rejects due to minor strip failures.

Line 17 Rolls of 0.035mm of copper tape. Copper means value so if it clear it is very thin then the value must be low!

I did not see the Lemo cables nor the BNC&Lemo Connectos (x100)

And the box;

The box requires a top! I did not see one.

I see that the box is truly full with expanded polystyrene "chips" which is good for protection. See photos.


